

MASTER RENTAL AGREEMENT & TERMS

ONE, TWO, CELEBRATE LLC

1. ACCEPTANCE OF TERMS By checking the "I agree" box and completing this reservation, the Customer ("You") enters into a legally binding agreement with One, Two, Celebrate LLC ("Company"). This agreement governs the rental of decorative inflatable products ("Equipment") and replaces the need for a physical signature.

GENERAL TERMS (APPLY TO ALL RENTALS)

2. DELIVERY, ACCESS & PICKUP

Delivery Zone: Service is provided only within Montgomery County, Maryland.

Drop-off Window: Delivery occurs between 7:00 AM and 10:00 AM on the date of reservation.

Placement: Equipment will be dropped off at the front porch (or previously designated area) in a storage bag or plastic bucket containing the rental items.

Pickup: Occurs between 7:00 PM and 9:00 PM on the date of reservation.

Customer Readiness: Customer must have equipment ready for pickup prior to 7:00 PM (see product-specific requirements in Section B or C). A \$50 fee applies if equipment is not ready for the driver at pickup time.

Wait & Return Fees: If the driver arrives and the equipment is not accessible or ready, the Company reserves the right to charge a Wait Fee of \$1.00 per minute or a Return Trip Fee of \$50.00.

Overnight/Extra Day: If equipment cannot be retrieved during the 7:00 PM – 9:00 PM window due to a lack of access, you will be charged for an additional day's rental fee.

3. PAYMENT & CANCELLATION (RAINCHECK & REFUND POLICY)

Retainer: A 20% non-refundable retainer is required to secure the date and specific equipment.

Final Balance: The remaining 80% balance is due 48 hours prior to delivery date.

Refund Policy: Cancellations made up to the delivery window time are eligible for an 80% refund of the total booking cost.

Weather Raincheck: Cancellations made by 7:00 AM on the event day due to inclement weather are eligible for a refund of the final balance; however, the 20% retainer will be retained

as a Raincheck credit valid for one year. No refunds or credits of any kind are issued once delivery has occurred or after 7:00 AM on the day of the event.

No Refunds after Delivery: Once delivery has occurred, no refunds or credits are issued for any reason.

Weather Interruptions: Your safety is our priority. If winds reach 15 mph or if it begins to rain, you must take appropriate action to secure equipment (see product-specific requirements in Section B or C). Please note that no refunds or rainchecks are issued for weather interruptions once equipment has been delivered.

4. CREDIT CARD AUTHORIZATION Customer explicitly authorizes One, Two, Celebrate LLC to charge the credit card used for the initial retainer for any additional costs incurred, including:

- Damage repairs or full replacement (up to \$1,500).
- Cleaning fees (see product-specific schedule in Section B or C).
- Wait fees (\$1/min) or return trip fees (\$50).
- Unpaid balances (80%) not settled 48 hours prior to delivery.

These charges may be processed immediately upon discovery of damage or loss.

5. LIABILITY WAIVER & INDEMNIFICATION

- **Waiver:** Customer releases Company from all liability for injuries resulting from misuse, unsafe behavior, or improper supervision. Customer assumes all risk for operation.
- **Indemnification:** Customer agrees to indemnify and hold One, Two, Celebrate LLC harmless from any claims, injuries, or damages resulting from the use of the equipment.
- **Governing Law:** This agreement is governed by the laws of the State of Maryland.

6. PHOTO PERMISSIONS By completing this booking, you grant One, Two, Celebrate LLC permission to photograph the inflatable setup for marketing purposes unless you opt-out by emailing us.

SECTION B: INFLATABLE RENTAL — SPECIFIC TERMS

7. NATURE OF EQUIPMENT (DECORATIVE USE ONLY) Customer acknowledges that the Inflatable is for decorative purposes only.

- It is NOT a bounce house or a play structure.
- It is NOT designed to support weight.
- Climbing, hanging, sitting, jumping, or riding on any Equipment is strictly prohibited.
- Customer assumes full responsibility for preventing misuse and supervising children at all times.

8. SETUP & SITE REQUIREMENTS The Customer is solely responsible for:

- **Manual Setup:** One, Two, Celebrate LLC provides delivery only. You are responsible for carrying, inflating, and anchoring the unit.
- **Surface:** Must be a flat, level surface (grass, turf, pavement, or carpet). Setup on rocky, thorny, or jagged surfaces is strictly prohibited.
- **Power:** A dedicated electrical outlet must be available within 50 feet of the setup area.
- **Pickup Readiness:** The Inflatable must be deflated, dried, and repacked in its storage bag prior to 7:00 PM on the pickup date.

9. INSPECTION, DAMAGE & LOSS

- **Immediate Inspection:** Upon arrival for pickup, the Company driver will perform a visual inspection and take time-stamped photos of the condition.
- **Reporting:** Any visible damage, mud, or prohibited items (confetti/glitter) found will be noted immediately in our system.
- **Replacement Value:** If an item is lost, stolen, or irreparably damaged, the Customer agrees to be charged the full replacement value (see Section 6).

10. SCHEDULE OF REPLACEMENT VALUES The Equipment you are renting is professional-grade, custom-designed, and limited edition. In the event of loss, theft, or irreparable damage, the Customer agrees to pay the full replacement cost of the item(s) as listed below:

- Giant Inflatables (Castles, Volcano etc.) \$1,500.00
- Large Inflatables (Unicorn, Dragon, Snail, etc.) \$899.00
- Decorative Arches \$300.00
- Small Props (Bunnies, Clouds, etc.) \$150.00
- Accessories (Storage bags, sandbags, stakes) \$50.00 (per item)

Note: Replacement costs cover the custom manufacturing, international freight, and limited-edition design rights of One, Two, Celebrate! exclusive inventory.

11. PROHIBITED ITEMS & CLEANING FEES

Strictly Prohibited: Silly String, confetti, glitter, slime, food, drinks, or face paint in or around the unit.

Cleaning Fee: A minimum \$75.00 cleaning fee will be automatically charged if the unit is returned with mud or any prohibited items listed above.

SECTION C: GIANT BUBBLE STATION — SPECIFIC TERMS

12. NATURE OF EQUIPMENT (ACTIVITY USE ONLY) Customer acknowledges that:

- The Giant Bubble Station is designed for supervised bubble-making activity with proper technique.
- Bubble Potion No. 1 is for outdoor use only and is not for consumption.
- Customer assumes full responsibility for supervising all users and ensuring proper handling of bubble solution.
- **Minimum Age:** Children under 3 years old should not use bubble wands or come into direct contact with bubble solution.
- **Supervision Recommendation:** Adult supervision is recommended for all children under 12 years old using the bubble station.

13. SETUP & SITE REQUIREMENTS (GIANT BUBBLE STATION) The Customer is solely responsible for:

Supervision: One, Two, Celebrate LLC provides the equipment only. You are responsible for supervising all users and ensuring proper bubble-making technique.

Slippery Surface Warning: Bubble solution can make surfaces slippery when it lands or spills. We strongly recommend setting up the bubble station on grass or a non-slip mat to prevent falls and injuries. Avoid hard, smooth surfaces (concrete, tile, deck, pavement) unless protected with a non-slip mat. Customer assumes all risk and liability for slip, fall, or injury resulting from wet or slippery surfaces created by bubble solution.

Weather Awareness: Bubble stations work best in slight humidity and calm winds. High winds (15+ mph) may reduce giant bubble quality. No refunds or rainchecks are issued for weather impacts once equipment is delivered.

Water Access: Have access to water for rinsing equipment during or after use (recommended for optimal bubble quality and ease of cleaning).

Pickup Readiness: Equipment must be returned clean and free of hardened or dried bubble solution residue, and repacked into the iridescent tote bag and 5-gallon bucket as received prior to 7:00 PM on the rental date.

14. INSPECTION, DAMAGE & LOSS (GIANT BUBBLE STATION)

Immediate Inspection: Upon arrival for pickup, the Company driver will perform a visual inspection and take time-stamped photos of the condition.

Cleaning Standard: Equipment must be returned clean and free of hardened or dried bubble solution residue. Light rinsing with water is acceptable.

Reporting: Any visible damage, or missing items will be noted immediately in our system.

Replacement Value: If an item is lost, stolen, or irreparably damaged, the Customer agrees to be charged the full replacement value (see Section 15).

15. SCHEDULE OF REPLACEMENT VALUES (GIANT BUBBLE STATION) The Equipment you are renting is professional-grade and custom-designed. In the event of loss, theft, or irreparable damage, the Customer agrees to pay the full replacement cost of the item(s) as listed below:

- Giant Bubble Wand | \$75.00
- Medium Bubble Wand | \$45.00
- Bubble Stick/Small Wand (each) | \$15.00
- 5-Gallon Bubble Potion No. 1 Bucket | \$40.00
- 2-Liter Bucket or Tray (each) \$15.00
- Decorative Sign | \$25.00
- Iridescent tote bag — wand storage | \$50.00

Note: Replacement costs cover custom manufacturing, international freight, and limited-edition design rights

16. BUBBLE POTION NO. 1 — HANDLING & SAFETY

Consumption Warning: Bubble Potion No. 1 is NOT for consumption. Keep out of reach of children under 3 years old.

Eye Contact: If solution contacts eyes, rinse thoroughly with water immediately. Seek medical attention if irritation persists.

Skin Contact: Generally safe; rinse with water if irritation occurs.

Disposal: Dispose of unused solution responsibly. Do not pour directly into storm drains or natural waterways.
